#10 - Changes Coming in 2022

#7 – Elections in a COVID Environment

In-person Meetings

If your chapter is fortunate enough to have access to a facility where you can meet in person, you'll want to pay close attention to these procedures for conducting an election meeting.

- Paper ballots should be prepared in advance.
- All members in attendance, who are assigned to the chapter, should be given a ballot.Voting must be done in person, except for absentee ballots which should have already
- been received by the officers.After voting and during the meeting, the elections committee members should count all
- ballots, including absentee ballots.The election results should be announced at the meeting.
- Within 10 days of the election, but no later than November 10th, the 2021 vice president should complete the <u>Election Verification Information</u> with the names of the 2022 officers.

When Meetings Can't Be Held in Person

In the event chapter members cannot meet in person, the officers may meet via Zoom or otherwise, to discuss a plan for moving forward.

- AAPC is giving 2021 officers permission to serve again, regardless of the number of years they have already served consecutively.
- If not all officers are available to serve during 2022, those who must step down can do so and the remaining officers can appoint replacements.
- If chapter members have expressed interest, whether nominated or not, those members could take the places of retiring officers.
- 2021 officers are allowed to appoint 2022 officers as they see best for the membership of the chapter. In the event officers cannot reach a consensus, the president will make the final decision.
- Three officers including a president, vice president, and secretary/treasurer are required to keep a local chapter active.
 - Six officers including a president, vice president, education officer, treasurer, secretary, and member development officer, are preferred.
- Once the 2022 officers have been decided upon, the 2021 vice president must report the information to AAPC by inputting the names online in the Election Verification Information.

#6 – CEU Tips from the Expert – How to "Save the Date"

Valerie Jones, from the CEU Vendor Team, shared the following information to increase proficiency when submitting applications for CEUs:

- If you are not using the beta application and are interested in posting a "Save the Date" select the 'Misc' event type and your request will bypass the CEU review process and be automatically uploaded to the website for membership viewing. Keep in mind that no CEUs will be awarded.
- Once you have secured a presenter and topic, then go back and submit your application as usual for CEUs.
 - In the "Additional Information for Analyst" box request your "Save The Date" event be removed from the website, upon approval.
- Fun titles are always welcome and approvable, however, double check that titles are professional and appropriate as they will be viewed online by the entire membership.
 - Events entitled 'TBA' or 'TBD' will not be approved for CEUs.
- Seminar applications should be completed fully.
 - Often an agenda is provided but completing the "Presentation Details" portion of the application for each presenter is forgotten.
 - This *delays approval* of your application.
- If you are using recorded information, the speaker on the recording is considered the presenter, not a chapter officer or member.

#5 - Changes are Happening Online

Have you noticed we are making updates and changes online in the "Events" area? See if you can spot these.

- Meetings and seminars are listed as "In-person" or "Virtual".
- You can now track attendance for seminars and review classes.
- You'll see "Mark Attendance" where you formerly saw "Pending", meaning the meeting is approved and ready for you to mark attendance.

#4 - Speakers Bureau

If you want to share information about a particular subject with your chapter members, the speakers bureau is a great asset. There are dozens of presentations available on a wide variety of topics. Go online and look for a presentation that suits your chapter. It's important to remember:

- The system is all automated.
- Topics are requested by date.
- These are virtual presentations only, therefore you must have your URL for the meeting in advance of making your request.
- After making a request, watch your email! Correspondence is by email only and it is the officer's responsibility to contact the speaker within a timely manner.

Each chapter may participate in the speakers bureau once a year. If you have not had a turn in 2021, it's not too late to apply!

#3 – Answers to Miscellaneous Questions

Q - How long does the vice president have to upload the names of the new 2022 officers online?

A – The election verification tool is open from October 1st through November 15th.

Q – If we are currently officers and will serve again in 2022, why do we have to upload the names of the officers into the election verification tool?

A – Officers are tracked by AAPC on a calendar year. If you are a 2021 officer and will also be a 2022 officer, your name must be listed for both years.

Q – If I accidently delete my officer news, where can I find access to the monthly Hot Sheet?

A – Online in the officer area under Training and News.

Q - How can I see how our chapter measures up against others statistically?

A – Online in the officer area under training and News.

#2 – October Deal of the Month

Entice members to attend your meetings regularly by informing them that they are eligible for the deal of the month, just by attending. Remember to download your October Hot Sheet before the meeting so you have easy access to the details. #1 - Financial Tasks for Treasurers to Accomplish in October

- Once you receive the September bank statement, go online into the <u>P&L tool</u> and input all income and expenses under the September tab.
- Upload the September bank statement in the September tab.
- If you held a meeting in September and have not yet marked attendance, be sure to mark attendance within 30 days, before the tool locks.
- If you hold a meeting in October, be proactive and mark attendance right away.
